ADMISSION NOTIFICATION

B.A./B.SC./B.COM.(General)/B.B.A./B.C.A. COURSE SEMESTER-I (2014) IN THE GOVT./ PRIVATE DEGREE COLLEGES AFFILIATED TO THE UNIVERSITY OF JAMMU FALLING UNDER SUMMER ZONE

It is hereby notified for the information of all concerned that the admission to Semester-I of the Six Semesters of Three Year B.A./B.Sc./B.Com. (General) /B.B.A./B.C.A. Course in the Govt./Private Degree Colleges affiliated to the University of Jammu falling under Summer Zone shall be made as under:-

- a) 17-06-2014 to 06-07-2014 without late fee
- b) 07-07-2014 to 16-07-2014 with late fee as prescribed by the University
- c) In case the seats are available, the Vice-Chancellor may consider grant of late admission for 10 days only after the expiry of last date as per (b) above on payment of late fee as prescribed by the University.

Thereafter no admission shall be made.

The regular teaching work of the class shall begin in the 3rd week of July, 2014

Admission of a candidate having been placed under re-appear in one subject only of the Higher Secondary Part-II examination (10+2 pattern) of the J and K State Board of School Education or an examination recognized as equivalent thereto subject to availability of seats and if otherwise found eligible, shall be allowed provisionally in the Govt. Colleges opened during 2005 onwards and Private affiliated colleges to the B.A./B.Sc./B.Com. (General) Course Semester-I on his/her own risk and responsibility subject to clearance of backlog of Higher Secondary Part-II as per University statutes.

ELIGIBILITY CONDITIONS:

(A) Bachelor of Business Administration (BBA) COURSE

Admission to Semester-I of BBA course shall be open to those candidates who have passed Higher Secondary Part-II examination (under 10+2 pattern) of the Jammu and Kashmir State Board of School Education or an examination recognized by the University as equivalent thereto and has obtained not less than 50% of the aggregate marks in the qualifying examination in case of General category candidates and 45% marks in case of SC/ST candidates.

(B) Bachelor of Computer Applications (BCA) COURSE

Admission of Semester-I of BCA course shall be open to those candidates who have passed Higher Secondary Part-II examination (under 10+2 pattern) of the J and K State Board of School Education or an examination recognized by the University as equivalent thereto with Mathematics as one of the elective subjects and has obtained not less than 50% of the aggregate marks in the qualifying examination in case of General category candidates and 45% marks in case of SC/ST.

NOTE:

1. The admission in the Govt. Colleges/Non-Government Colleges affiliated to University of Jammu shall be made directly by the Admission Committee of the College concerned on the basis of marks obtained by the candidate/s in the qualifying examination.


2. Non-Government Colleges shall follow the same admission schedule and procedure/students as are applicable for govt. Colleges.
3. The admission to Non-Local candidates in Non-Govt. Colleges shall be granted under the second preference category.


